Applicant hereby agrees that representatives of the Town are authorized to inspect animals prior to their use in activities upon the public way and to prohibit the use of animals found to be diseased, unhealthy or which pose a danger to the public health and safety.

Public sidewalks: Any demonstrating groups must leave room for passersby and may not block the flow of pedestrian traffic. If leafleting, demonstrators may not force a passerby to accept leaflets or harass individuals who refuse leaflets.

Public streets: Any march on the public street is typically considered a parade; therefore, the location and duration of the march are subject to regulation by the Town Council to prevent traffic problems. Marchers must obey all traffic laws during the march.

Others types of public property: Some types of public property are non-traditional public forums and therefore have special restrictions on free speech. A demonstration may not take place within the immediate vicinity of the Town Hall or other locations which would be in violation of municipal, county, state or federal laws, including but not limited to election laws.

The applicant must promptly reimburse the Town for (and make good to it) any and all damage of any kind to any property of the Town which may result from the use by the applicant of the Town's premises under the any permit granted hereupon, and the applicant further agrees that it will not hold liable the Town of Peterstown or any of its municipal officials for or in account of any losses or damage to property owned by it or controlled by the applicant or for or on account of any loss or damage sustained by the applicant as result of injuries to employees or agents of the applicant or event participants.

The applicant agrees to indemnify, save and keep and hold harmless the Town of Peterstown, its officers, agents and employees of and from any and all liabilities, liens, judgments, costs, damages and expenses which may be suffered by the Town and/or any of its officers, agents or employees or which may accrue against or be charged to or recovered from the Town or any of its officers, agents or employees for any damage caused by the applicant and/or any of the applicant's officers, agents, employees or any other persons for whom the applicant is responsible which may result from the use of the Town's premises under any permission granted herein.
